## MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE MEHLVILLE FIRE PROTECTION DISTRICT OF ST. LOUIS COUNTY, MISSOURI, ON THE 16TH DAY OF JUNE, 2021

The Board of Directors of the Mehlville Fire Protection District of St. Louis County, Missouri, met at the Mehlville Conference Room, 11020 Mueller Road, St. Louis County, Missouri, on the 16th day of June, 2021.

Present at the meeting were:

Aaron Hilmer, Chairman and Director of the Board;

Bonnie C. Stegman, Treasurer and Director of the Board;

Edmond Ryan, Secretary and Director of the Board; and

Brian Hendricks, Fire Chief of the Mehlville Fire Protection District.

Mr. Hilmer called the meeting to order at 5:00 p.m. and announced the Board to be in session for the transaction of business.

Mr. Ryan made a motion to pay the bills of June 9 and 16, 2021. Mr. Hilmer seconded the motion and it was unanimously approved.

Chief Hendricks recognized the efforts of crew members who responded to a 911 call for a full cardiac arrest on April 7, 2021, including Captain Jason Appel, Engineer John Lipina, Private James Teeple, Critical Care Paramedics Chris Ekiss and Janis Smith, and Acting Battalion Chief Lee Bennion. Chief Hendricks thanked the crew and introduced the patient, Carol Jacobsmeyer, and her husband described the events of the call. He said the dispatcher instructed him in CPR, which he performed, and she was kind enough to tell him that he did a good job. The crew arrived with incredible speed, just as Mr. Jacobsmeyer was getting tired. Through their teamwork and ability, they brought back a life that day. Mr. Jacobsmeyer thanked the crew. Acting Battalion Chief

Lee Bennion described the call from the perspective of the crew, highlighting the way treatment has changed from immediately transporting the patient to treating and stabilizing the patient on scene. He said the crew immediately could tell that Mrs. Jacobsmeyer was in a bad situation. He described in detail the roles of each crew member, and the lifesaving procedures they performed. He said that the crew are highly trained professionals who are good at what they do, but the person responsible for saving her life was her husband, who initiated CPR before the crew's arrival. Chief Hendricks presented crew members with certificates recognizing their contribution.

There being no further business, Mr. Hilmer adjourned the meeting at 5:20 p.m.
