MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE MEHLVILLE FIRE PROTECTION DISTRICT OF ST. LOUIS COUNTY, MISSOURI, ON THE 28TH DAY OF OCTOBER, 2015

The Board of Directors of the Mehlville Fire Protection District of St. Louis County, Missouri, met at the Mehlville Conference Room, 11020 Mueller Road, St. Louis County, Missouri, on the 28th day of October, 2015.

Present at the meeting were:

Aaron Hilmer, Chairman and Director of the Board;

Bonnie C. Stegman, Treasurer and Director of the Board;

Edmond Ryan, Secretary and Director of the Board; and

Brian Hendricks, Fire Chief of the Mehlville Fire Protection District.

Mr. Hilmer called the meeting to order at 5:00 p.m. and announced the Board to be in session for the transaction of business.

Dr. Stegman made a motion to pay the bills of October 21 and 28, 2015. Mr. Ryan seconded the motion and it was unanimously approved.

Dr. Stegman made a motion to approve Transport Ordinance #128. Mr. Ryan seconded the motion and it was unanimously approved.

Dr. Stegman discussed the rapid access system employed by St. Charles Fire Department. The key storage boxes are sold to residents by the fire department for \$25 and installed for free as necessary. A District resident asked Dr. Stegman if the same program could be implemented by Mehlville Fire Protection District. The knox boxes employed by the District cost about \$195. Chief Hendricks said that the District uses the Knox Box system because it is the most secure and utilizes a universal key as opposed to PIN numbers. He said he would investigate other programs and report back to the Board.

Dr. Stegman made a motion to approve the tuition reimbursement request of

Captain Roman Stolarski. Mr. Ryan seconded the motion and it was unanimously

approved.

Dean Eggerding from USI presented recommendations for the 2016 health

insurance renewal. He said that the District has seen a dramatic reduction in loss ratio

over the last three years. Anthem returned a 0% renewal and a benefit enhancement with

out-of-pocket maximums reduced. USI recommends staying with Anthem. USI is still

negotiating for vision and dental renewals. They recommend remaining with Unum for

life and disability insurance.

Mr. Hilmer then made a motion that a closed meeting be held for the purpose of

discussing a legal matter immediately following the adjournment of the regular meeting.

Mr. Hilmer, as part of said motion, moved that said closed meeting not be open to

members of the general public under the provisions of Chapter 610 of the Missouri

Revised Statutes, commonly referred to as the Sunshine Act. The motion was seconded

by Dr. Stegman. A roll call vote on said motion was taken.

Director Hilmer yea.


