MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE MEHLVILLE FIRE PROTECTION DISTRICT OF ST. LOUIS COUNTY, MISSOURI, ON THE 27th DAY OF MARCH, 2024

The Board of Directors of the Mehlville Fire Protection District of St. Louis County, Missouri, met at the Mehlville Conference Room, 11020 Mueller Road, St. Louis County, Missouri, on the 27th day of March, 2024.

Present at the meeting were:

Aaron Hilmer, Chairman and Director of the Board,

Bonnie C. Stegman, Treasurer and Director of the Board;

Edmond Ryan, Secretary and Director of the Board; and

Brian Hendricks, Fire Chief of the Mehlville Fire Protection District.

Mr. Hilmer called the meeting to order at 5:03 p.m. and announced the Board to be in session for the transaction of business.

Dr. Stegman made a motion to pay the bills of March 20 and 27, 2024. Mr.

Ryan seconded the motion and it was unanimously approved.

Chief Financial Officer Brian Bond presented the February 2024 Treasurer's Report. The District received \$387k in tax revenue in February. Cash equivalent resources totaled \$37.151M. Capital expenditures for February included \$90k in renovation costs, \$218k for six new stretchers, and \$58k for a new suburban staff vehicle. Both the General Fund and the Pension Fund appear to be on course with the budget. Dr. Stegman made a motion to approve the February, 2024 Treasurers Report. Mr. Ryan seconded the motion and it was unanimously approved.

Regular Meeting March 27, 2024

Chief Hendricks discussed changes to the EMoPP. He will meet and confer with the Union Shop and bring back any recommendations to the Board at the next meeting.

Mr. Hilmer made a motion that a closed meeting be held for the purpose of discussing personnel matters immediately following the adjournment of the regular meeting. Mr. Hilmer, as part of said motion, moved that said closed meeting not be open to members of the general public under the provisions of Chapter 610 of the Missouri Revised Statutes, commonly referred to as the Sunshine Act. The motion was seconded by Mr. Ryan. A roll call vote on said motion was taken.
