MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE MEHLVILLE FIRE PROTECTION DISTRICT OF ST. LOUIS COUNTY, MISSOURI, ON THE 24th DAY OF APRIL, 2024

The Board of Directors of the Mehlville Fire Protection District of St. Louis County, Missouri, met at the Mehlville Conference Room, 11020 Mueller Road, St. Louis County, Missouri, on the 24th day of April, 2024.

Present at the meeting were:

Aaron Hilmer, Chairman and Director of the Board,

Bonnie C. Stegman, Treasurer and Director of the Board;

Edmond Ryan, Secretary and Director of the Board; and

Brian Hendricks, Fire Chief of the Mehlville Fire Protection District.

Mr. Hilmer called the meeting to order at 5:03 p.m. and announced the Board to be in session for the transaction of business.

Dr. Stegman made a motion to pay the bills of April 17 and 24, 2024. Mr. Ryan seconded the motion and it was unanimously approved.

Chief Financial Officer Brian Bond presented the March 2024 Treasurer's Report. The District received \$236k in tax revenue. Cash equivalent resources totaled \$35.287M. Capital inflows for March included \$100k from sale of a pumper and \$1k from a donation for the future baby box at House 5. Capital expenditures included \$38k in renovation costs, \$545k for two new ambulances, and \$9k for computer equipment. Both the General Fund and the Pension Fund appear to be on course with the budget. Dr. Stegman made a motion to approve the March, 2024 Treasurers Report. Mr. Ryan seconded the motion and it was unanimously approved.
