

MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS
OF THE MEHLVILLE FIRE PROTECTION DISTRICT OF
ST. LOUIS COUNTY, MISSOURI, ON THE
11th DAY OF JUNE, 2025

The Board of Directors of the Mehlville Fire Protection District of St. Louis County, Missouri, met at the Mehlville Conference Room, 5721 S. Lindbergh Blvd., St. Louis County, Missouri, on the 11th day of June, 2025.

Present at the meeting were:

Aaron Hilmer, Chairman and Director of the Board,

Bonnie C. Stegman, Treasurer and Director of the Board;

Edmond Ryan, Secretary and Director of the Board; and

Brian Hendricks, Fire Chief of the Mehlville Fire Protection District.

Mr. Hilmer called the meeting to order at 5:00 p.m. and announced the Board to be in session for the transaction of business.

Dr. Stegman made a motion to pay the bills of June 3 and 11, 2025. Mr. Ryan seconded the motion and it was unanimously approved.

Mr. Ryan made a motion to approve the minutes of May 1, 14, and 28, 2025. Dr. Stegman seconded the motion and it was unanimously approved.

Chief Financial Officer Brian Bond presented the 2024 Annual Comprehensive Financial Report. Both the General Fund and the Pension Fund appear to be on course with the budget. Dr. Stegman made a motion to approve the March 2025 Treasurer's report. Mr. Ryan seconded the motion and it was unanimously approved.

Chief Brian Hendricks presented changes to the EMoPP. Dr. Stegman made a motion to approve the EMoPP changes. Mr. Ryan seconded the motion and it was unanimously approved.

Chief Brian Hendricks discussed the new Transfer Division and billing rates. Dr. Stegman made a motion to approve the billing rates for the Transfer Division. Mr. Ryan seconded the motion and it was unanimously approved.

Mr. Ryan read the Director Oath of Office and was sworn in by Chief Hendricks for a term of six years that will expire at the April, 2031 election.

Mr. Hilmer made a motion that a closed meeting be held for the purpose of discussing personnel matters immediately following the adjournment of the regular meeting. Mr. Hilmer, as part of said motion, moved that said closed meeting not be open to members of the general public under the provisions of Chapter 610 of the Missouri Revised Statutes, commonly referred to as the Sunshine Act. The motion was seconded by Mr. Ryan. A roll call vote on said motion was taken.
